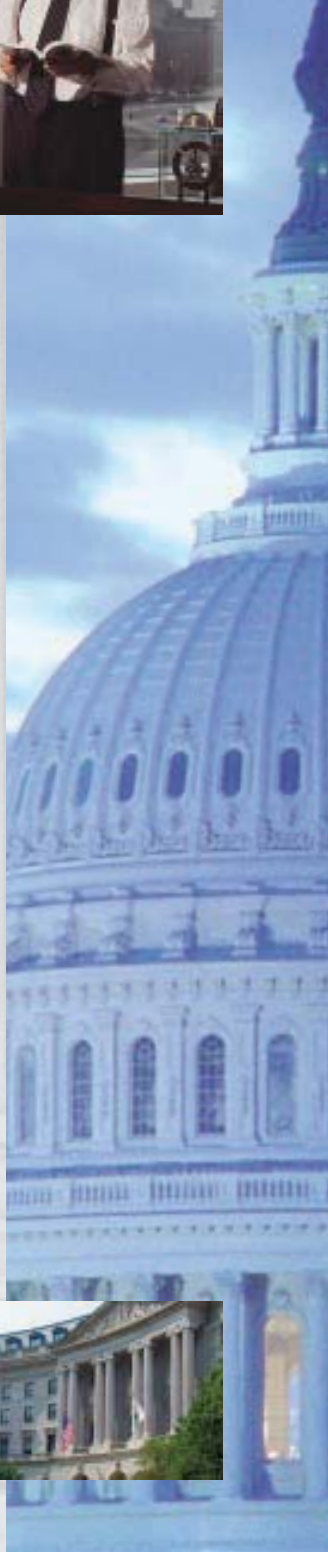

#### **AWARD PROTESTS AND DEFENSES**

VSK attorneys have extensive experience both in bringing and in defending against protests for clients regarding the propriety of the government's contract award process. VSK provides legal expertise in bid protest actions before various contracting agencies, the General Accounting Office, the Court of Federal Claims, and the Court of Appeals for the Federal Circuit.

#### **CONTRACT ADMINISTRATION, CLAIMS AND DISPUTES**

After the award of the government contract, VSK advises and represents clients in negotiating and resolving matters of contract interpretation and performance. When unable to resolve disputes through negotiation, VSK represents clients in pursuing claims, appeals and contract litigation before various Boards of Contract Appeals, the Court of Federal Claims, and the Court of Appeals for the Federal Circuit.

#### **FOREIGN OWNERSHIP, CONTROL OR INFLUENCE**

VSK assists clients who are subject to foreign ownership, control or influence in obtaining and maintaining security clearances for classified and nuclear sensitive contracts by properly constructing agreements to the satisfaction of the United States government through board resolutions, voting trusts, proxy agreements, and special security agreements.

#### **COMPLIANCE AUDITS**

VSK encourages a proactive approach by conducting internal legal investigations and compliance audits at the request of clients and putting systems in place at the company to avoid or resolve problems before they become crises.

#### **PROCUREMENT FRAUD**
